The Findlay branch office will offer additional conveniences to the residents and businesses in and around Findlay. The Findlay branch employees have been informed of their obligations under the Community Reinvestment Act and the federal fair lending laws. They are well trained in the roles of quality customer service. Additionally, having a branch in Findlay allows Shelby County State Bank to ascertain credit needs, market credit product, and identify potential community development projects on an ongoing basis. The officers and employees of the Findlay branch are in an excellent position to gather community information for the bank and they have sufficient loan authority to respond and are fully integrated into the lending decision process. The officers of the Findlay branch office have been included in the Shelby County State Bank officer-call program, and have been instructed to contact those individuals which are knowledgeable about credit needs; for example, community organizations, local churches, business association, and local governmental agencies in and around Findlay. As the employees perform their customary business calls, participate in community volunteer efforts, or talk to customers who come to the bank, they will be trained to recognize opportunities for the bank to meet credit needs.
